

TERMS AND CONDITIONS
The RHB Bank Credit Card Flash Promo (15 October 2021 – 15 November 2021) Campaign

Intelligent Money Sdn Bhd (Company No. 1005180-T) shall be referred to as “iMoney” or “the Company”.

The RHB Bank Credit Card Flash Promo (21st October 2021 – 31st December 2021) Campaign will be referred to as “the Campaign” or “Campaign”.

CAMPAIGN PERIOD

The Campaign shall run from 23:59:59 Malaysian time (UTC+8) on 21st October 2021 to 23:59:59 Malaysian time (UTC+8) on 31st December 2021.

CAMPAIGN ELIGIBILITY

- 1) The campaign is open to citizens of Malaysia.
- 2) The campaign is open to salaried customers between the age of 21-year-old and above.
- 3) The applicable product, herein referred to as “Product” for singular form, for this campaign include the following available on iMoney’s website:
 - a) RHB Shell Visa Credit Card/-i
 - b) RHB Cash Back Credit Card
- 4) The Customer Details submission must be made during the Campaign Period.
- 5) The customer who successfully applies must also submit all required information for processing the credit card application, herein referred to as “Customer details”, by **23:59:59 Malaysian time on 31st December 2021**. The Required Details are as follow:
 - a) Customer Name
 - b) Customer IC
 - c) Customer Phone Number
 - d) Customer Email Address
 - e) Employment Type
- 6) The customer must successfully submit all required details as listed above for the RHB credit card application by 23:59:59 Malaysian time on 31st December 2021.
- 7) Staff of Intelligent Money Sdn Bhd or Juris Technologies Sdn Bhd are not eligible to participate in the Campaign.

CAMPAIGN MECHANICS

- 1) The Campaign is only for applications to the aforementioned Product via the iMoney.my website.
- 2) After applying for the Product, iMoney may contact the customer via phone call to further conduct screening for the product – this is not to be confused with campaign eligibility.
- 3) iMoney, will be tracking the date of submission of Required Details by each customer in ensuring that Campaign Eligibility is fulfilled.
- 4) Only iMoney customers with completed Details submission for the products that fulfil the Campaign Eligibility criteria shall be considered for the Campaign. The time shall be based on iMoney's server system time.

- 6) The RHB Bank Credit Card Flash Promo mechanics as follow:
